RE: PRODUCT APPROVAL FOR THE OZZI KLEEN GTS10 GREYWATER TREATMENT SYSTEM

We refer to your application seeking product approval for the GTS10 on-site domestic greywater treatment unit.

Approval of the product is granted on the basis that the product has been certified by SAI Global to conform with:

 DGTS:2005 – NSW Health Department: Domestic Greywater Treatment Systems (DGTS) – Accreditation Guidelines – February 2005, as demonstrated by StandardsMark Licence SMKH20282.

Pursuant to the South Australian Public Health (Wastewater) Regulations 2013, product approval is subject to the following conditions:

- 1. The approved product incorporate:
 - 1.1. 4150L Roto moulded polyethylene cylindrical tank (model PT 4000) as the main treatment tank.
 - 1.2. 1640 L Roto moulded polyethylene cylindrical tank (model PS 1500) as the pump chamber and chlorine contact tank.
 - 1.3. Rietschle Thomas LP80-HN air blower rated at 85 L/min and an Elastox-T type B diffuser.
 - 1.4. Suitable submersible pump rated at 40 L/min @ 8m head.
 - 1.5. Audio-visual in-house alarm system.
 - 1.6. Maximum treatment capacity 2000L/day (10 persons at 200 L/person/day) hydraulic load and 60g BOD5/person/day organic load.
- 2. The products shall be manufactured and constructed in accordance with:
 - 2.1. The plans, drawings and specifications, as referenced in this approval.

- 2.2. AS/NZS 1546.1:2008 On-site domestic wastewater treatment units Septic tanks.
- 2.3. All other relevant standards and codes.
- 2.4. Conditions of this approval.
- 3. The seller of the approved product shall provide the purchaser with an electronic or hard copy of:
 - 3.1. The Owner's Manual for OZZI KLEEN Greywater Treatment Plant Model GTS10
 - 3.2. The Installation Manual for OZZI KLEEN Greywater Treatment Plant Model GTS10
 - 3.3. Any other instructions relating to the installation, operation or maintenance of the product.
- 4. Modification of the design, materials or manufacturing process of the approved products or any of their associated components requires a variation to this approval by the Department for Health and Wellbeing.
- 5. The product approval will expire on 20 July 2025, at which time the products will no longer be approved and will be removed from the SA Health approved product database.
- 6. This product approval does not constitute approval for the installation of the product.
